Chellaston Infant and Junior Schools do not permit mobile phones to be brought into school. Phones are expensive items and we cannot guarantee safety or security. This rule is also in place for safeguarding reasons – we cannot filter content to ensure it is appropriate for children if this is accessed on mobile phones. In addition the taking of photographs etc. needs to be strictly controlled according to parental wishes. **Therefore we ask for your support in NOT sending mobiles into school.**

However, we also recognise there may be occasional exceptional circumstances where it is helpful for a pupil to bring a mobile phone into school, for instance, if they walk to school unaccompanied in years 5 and 6. Whilst we will not permit the use of the phone during the school day, in these exceptional circumstances we will consider a parental request for a pupil to be able to access a phone, before or after school (NOT merely because a pupil wants to have their phone).

In these circumstances we ask parents and carers to read the following agreement and sign the request, stating the specific reason for a phone to be in school.

Our Pupil Mobile Phone Rules

- All pupils bringing a phone into school must have a good reason for doing so, and must have returned this agreement.
- The school will help children to learn about staying safe online, but recognises that the primary responsibility for online safety at home lies with parents/carers. The school will seek to work with families to help them to encourage children to adopt safe use of mobile technology.
- Children not following these rules will not be allowed to bring a phone into school. Any phone brought in without permission will be confiscated and only returned to a parent or carer. Schools are permitted to confiscate phones from pupils under sections 91 and 94 of the [Education and Inspections Act 2006](#)
- Phones should not be used in the vicinity of the school (the area outside the school gates).
- Children should be reminded not to take photographs or videos of people without asking and never to take them on the way into or out of school.
- All phones should be turned off before entering the school premises and handed in to the teacher at the start of the school day
- **The school cannot accept responsibility for damage or loss of a mobile phone brought into school.**
- The school has the right to confiscate or search a mobile phone (as set out in the [DfE's guidance on searching, screening and confiscation](#)). In the unlikely event of needing to do this, we will endeavour to contact a parent or carer. As part of this agreement, your child should agree to unlock the phone if required by a member of staff.
- We do not allow pupils to wear Smart Watches in school.

Mobile Phone Agreement Our Pupil Mobile Phone Rules

- The school has the right to confiscate or search a mobile phone. In the unlikely event of needing to do this, we will endeavour to contact a parent or carer. As part of this agreement, your child should agree to unlock the phone if required by a member of staff.
